Directions for use:

Opal Green is a surface biocide for professional use against moulds, fungi and algae that contaminate external hard surfaces such as roofs, driveways, pathways and around buildings.

Application Rates:

5 litres per 1,000m² in 50 litres of water

50 litres per Ha in 500 litres of water

Application Method:

Opal Green can be applied by brush, mop and ideally be surface spray. It is essential that all areas to be cleaned are thoroughly wetted with the product.

Opal Green works on contact and continues to work for 5 to 7 days after application.

Many of the cushion mosses can be difficult to control due to their dense growth habit so can exhibit variable susceptibility to moss treatment. In some instances a second treatment may be necessary. All surfaces may be used after the application has dried. A new solution of Opal Green should be made up daily. Opal Green does not produce any odour.

For use only be professional operators.
