### 2 COMPOSITION/INFORMATION ON INGREDIENTS

**COMPOSITION COMMENTS:** Proprietary non-hazardous blend.

### 3 HAZARDS IDENTIFICATION

### 4 FIRST AID MEASURES

**INHALATION:** Move the exposed person to fresh air at once. Rinse nose and mouth with water. Get medical attention if any discomfort continues.

**INGESTION:** DO NOT INDUCE VOMITING! Rinse mouth thoroughly. Get medical attention. Provide rest, warmth and fresh air.

### 5 FIRE FIGHTING MEASURES

**EXTINGUISHING MEDIA:** Use: Water spray. Powder. Carbon dioxide (CO<sub>2</sub>). Alcohol resistant foam.

**SPECIAL FIRE FIGHTING PROCEDURES:** Avoid water in straight hose stream; will scatter and spread fire. Containers close to fire should be removed or cooled with water. Keep run-off water out of sewers and water sources. Dike for water control.

**HAZARDOUS DECOMPOSITION PRODUCTS:** Fire creates: Carbon monoxide (CO). Carbon dioxide (CO<sub>2</sub>).

**PROTECTIVE MEASURES IN FIRE:** Suitable self-contained breathing apparatus should be used in confined areas.

### 6 ACCIDENTAL RELEASE MEASURES

**SPILL CLEANUP METHODS:** Absorb in vermiculite, dry sand or earth and place into containers. Flush with plenty of water to clean spillage area.
