

PRECAUTIONS

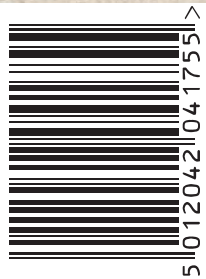

For flat, hard surfaces apply 10g of product per square metre of surface.
For ant nests in grass apply 20g of product per square metre.
