N.B Prior to applying Nippon Ant Killer Liquid², pierce the 4 small indentations on station base with a sharp point to allow ants access to the bait.

DIRECTIONS FOR USE

Undo cap and pierce the end seal. Clear up other readily available foodstuffs. Place 3-4 drops (0.3-0.4g) of product per bait point, preferably in the late evening, into the refillable bait station by the ant run. Change the bait daily until ant activity ceases (usually 7 to 10 days). Replenish as necessary. Do not disturb feeding ants, which pass Nippon onto the entire colony. Ants are only controlled if Nippon is the main food source.

When used outdoors use a maximum of 3 refillable bait points. Effective for up to 1 month.

Wash hands and exposed skin before meals and after use. Prevent access to bait by children and animals. Keep in a safe place. Hazardous to bees. Do not use where food, feed or water could become contaminated. There should be an interval of at least 7 days between 28-day treatment campaigns.

Remove all remains of bait and bait containers. Do not contaminate surface water or drains with chemicals or used container. Do not re-use container (empty tube).
