## **RATES OF USE:**

Presitage Super Spray Tank & Machinery Cleaner at the rate of 500ml per 100ltrs of tank capacity.

## **DIRECTIONS FOR USE—INTERNAL SPRAY TANK:**

Half fill the tank with clean water and add full amount of Prestige Super Spray Tank & Machinery Cleaner at the rate of 500ml per 100ltrs of tank capacity. Flush the cleaner solution through the entire system, ensuring that boom end valves are open and/or bungs removed for a complete boom treatment. Close boom end valves and/or replace bungs once cleaner solution is freely flowing from the ends of the booms. Top up the tank until filled with clean water and allow to stand for 15 minutes with the agitation running. Flush all of the solution out of the spray tank via the spray boom lines and nozzles. Nozzles, screens, filters and non-drip diaphragms should be removed and washed separately with the cleaner at the rate of 50ml in 10ltrs of water. Drain tank and flush the entire system with clean water.

## **DIRECTIONS FOR USE—EXTERNAL MACHINERY:**

Place Prestige Super Spray Tank & Machinery Cleaner into a bucket at the rate of 50ml per 10ltrs water. Wearing gloves and protective clothing, use a sponge to cover the machinery in Prestige Super Spray Tank & Machinery Cleaner. Scrub well where required ensuring the machinery is completely covered leave the solution on the equipment for 15 minutes before rinsing off with clean water.

## **PRECAUTIONS & HAZARD STATEMENT:**

**Causes severe skin burns and eye damage.**

Precautions: Wear protective gloves/face protection/protective clothing/protective footwear.

**IF IN EYES:** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
