

DIRECTIONS FOR USE

Ranger-Pro is a professional biocide for use on external hard surfaces, including: roofs, driveways, pavements, concrete, around buildings and on artificial sports surfaces such as tennis courts to control moulds, fungi and algae.

Ranger-Pro is ideally applied as a spray. It can also be applied by brush or mop. It is essential that all areas to be cleaned are thoroughly wetted with the product. **Ranger-Pro** works on contact and continues to work for 5 to 7 days after application. In some instances a second treatment may be necessary. All surfaces may be used after the application has dried.

A new solution of Ranger-Pro should be made up daily.

Contains: Didecyl dimethyl ammonium chloride 3.75% & Quaternary ammonium compounds, benzyl-C12-16-alkyldimethyl, chlorides 7.5%.
